Thanks so much for your enduring commitment to Fort Mason Center for Arts & Culture (FMCAC). In an effort to ensure greater transparency and accountability to the community we serve, I'm excited to present our new annual report for 2023.

Your financial support helps make art accessible to the public throughout the year, while also enabling FMCAC to offer affordable space to 20 nonprofit resident organizations, including the American Indian Cultural District, profiled here.

This past year, the Fort Mason Art program presented an adventurous array of free art experiences, including the return of our Gallery 308 marquee exhibition, new outdoor murals and flags, and the debut of seasonal Art Walks. FMCAC's capital projects program invested over \$3 million and thousands of staff hours in preserving and improving our historic piers and storehouses, from pouring a new concrete slab in Building B to transforming Pier 2 into our newest event venue, the Gateway Pavilion. This work enables us to keep our doors open, literally.

With grant support from the National Park Foundation, we are currently developing a three-year strategic plan in anticipation of Fort Mason Center's 50th anniversary in 2027. The Fort Mason 50 plan will articulate an inclusive, actionable vision for the future. As a member of our broader community, we will be inviting your input on what makes this place so special. I hope you will participate.

The Fort Mason Art program transforms this former Army base into a launching site for memory, present-tense assembly, and future imagination. Over the past decade, Fort Mason Art has evolved into a robust, year-round calendar of free exhibitions, public art, performances, and seasonal Art Walks.

In January 2023, Fort Mason Art celebrated the opening of Sunny A. Smith's *The Compass Rose*, a new commission for Gallery 308. The exhibition is the artist's meditation on ancestral lineage repair, featuring interpretations of family heirlooms, mystical objects, and family trees, each imbued with unique symbolism and meaning.

Artist Cauleen Smith's flag series, Seven Swallowtail Flags: Shiny Things for My Quartermaster, debuted atop Pier 2 and Pier 3 in September 2023. Each flag is a nod to Fort Mason's history, specifically, the black quartermasters who served during World War II. Smith embraces and subverts the visual language of military symbology, including crossed swords, an American eagle, and the Quartermaster's key.

Throughout 2023, Fort Mason Art piloted a series of three Art Walks in collaboration with FMCAC resident organizations, including FOR-SITE Foundation, Goody Café, Haines Gallery, Long Now Foundation, Museo Italo Americano, SF Camerawork, and San Francisco Children's Art Center. Drawing over 1,500 attendees, each Art Walk featured special performances and exhibitions, from operatic virtuosos to contemporary dance. This popular seasonal event has become a permanent staple of Fort Mason Art's annual calendar.





# FACES OF FORT MASON: AMERICAN INDIAN CULTURAL DISTRICT

Founded in 2020, the American Indian Cultural District (AICD) is the first established cultural district of its size in the United States dedicated to recognizing, honoring, and celebrating the American Indian legacy, culture, people, and contributions.

Since 2021, AICD's American Indian Cultural District Hub office has been located at Fort Mason Center. The space serves as a collective working hub for multiple organizations, including the Association of Ramaytush Ohlone and the American Indian Film Institute. In addition to being across from Alcatraz, home of the notable 1969 American Indian occupation, its waterfront location is culturally significant for American Indians. As explained by Sharaya Souza, AICD's executive director and co-founder, "For American Indians, water is sacred, the origin of all life, and the starting point for many of our creation stories."

In April 2023 FMCAC and AICD collaborated on a lobby art installation in Building D featuring re-printed posters highlighting the history and connection of American Indian organizations and events to Fort Mason Center, from 1980 to the present. Commissioned by AICD with support from FMCAC, this installation and accompanying land acknowledgement foster a sense of belonging for American Indian organizations within and visitors to the hub.
